INDICATION AND USAGE

VYJUVEK is a topical gel indicated for the treatment of wounds in patients 6 months of age and older with dystrophic epidermolysis bullosa (DEB) with mutation(s) in the *collagen type VII (COL7A1)* gene.

WARNINGS AND PRECAUTIONS

Accidental Exposure to VYJUVEK gel: VYJUVEK will not replicate in the subject's cells and does not integrate into the subject cells' native genetic material. For precautions, avoid direct contact with treated wounds (e.g., touching or scratching) and dressings of treated wounds for approximately 24 hours following treatment.

Krystal Connect provides personalized support for your patients during their VYJUVEK™ (beremagene geperpavec-svdt) treatment journey. Services include:



Educating patients about VYJUVEK and living with DEB

- Provide education and answer questions about VYJUVEK
- Provide resources and help connect patients with programs about DEB and VYJUVEK

Providing insurance coverage support



- Assist with the insurance process, including benefits investigation and prior authorizations
- Informing patients about potential financial assistance options and eligibility requirements as needed. Options include:
 - \$0 Co-pay Program*: for those who are eligible and commercially insured, this program may reduce out-of-pocket costs for qualified patients to as low as \$0
 - Patient Assistance Program†: for eligible patients without insurance, or who may have insurance but don't have VYJUVEK coverage, our Patient Assistance Program may be able to provide VYJUVEK at no cost
 - If it is determined that a patient is not eligible for a Krystal Connect financial assistance program, Krystal Connect may be able to help them find charitable organizations that may offer third-party assistance



Supporting with treatment logistics

- Helping patients evaluate appropriate administration site options, either in a healthcare professional setting or a home setting
- Sharing information with patients about what to expect when they go for treatment and helping coordinate weekly treatments

*Patient Eligibility & Terms and Conditions: the VYJUVEK Co-pay Program is available only to commercially insured patients with a valid prescription for VYJUVEK. Patients must be US citizens or residents for at least six months. Patients or their guardian must be 18 years of age or older to enroll in the program. **Patients are not eligible for co-pay assistance through the VYJUVEK Co-pay Program if they are cash-paying patients, or enrolled in any state or federally funded programs for which drug prescriptions or coverage could be paid in part or in full, including, but not limited to, Medicare Part B, Medicare Part D, Medicaid, Medigap, VA, DoD, or TRICARE (collectively, "Government Programs"), or where prohibited by law.** This offer is not health insurance. The VYJUVEK Co-pay Program applies only to out of pocket costs associated with VYJUVEK and not the cost of related medical services. In any calendar year commencing January 1, the maximum co-pay benefit amount paid by Krystal Biotech, Inc. will be \$15,000. Eligible patients may pay as little as \$0 per prescription, up to the annual maximum co-pay assistance amount of \$15,000. Additional terms and conditions apply. †The VYJUVEK Patient Assistance Program (PAP) is designed to provide VYJUVEK at no cost to eligible patients who meet certain financial need and insurance coverage eligibility criteria. Patients may be eligible to receive free drug if they demonstrate qualifying financial need, are uninsured or functionally uninsured, are US citizens or residents for at least six months, and have a valid prescription for VYJUVEK as supported by information provided in the program application. Eligibility does not guarantee approval for participation in the program. The PAP does not cover the cost of previously purchased product or medical services. Patient Access Liaisons (PALs)

PALs can help patients with treatment coordination, and can help with a broad range of topics, such as insurance coverage and financial assistance. PALs are experts in health insurance and helping patients understand the healthcare system.



Community Education Liaisons (CELs)

CELs have backgrounds in nursing or genetic counseling. They can provide education and help answer questions about DEB and treatment with VYJUVEK. They can share information about programs and events tailored to the DEB community.

How to get patients started on VYJUVEK™ (beremagene geperpavec-svdt)

Follow the steps below to get your patients started by enrolling them in Krystal Connect, a personalized patient support program.

Prescribe and enroll:
